INDEMNITY AND WAIVER AGREEMENT

I acknowledge and agree to accept the following by applying for membership and understand that if I choose not to accept the following I should not apply for membership in Diva Angels, Inc., a Florida not for profit corporation or its chartered chapters and their respective members, directors, employees and/or agents:

- a I acknowledge that participation in this organization and any of its events is a voluntary act, which is recreational and naturally includes a degree of risk to personal safety and property; I voluntarily accept that risk and assume its consequences.
- b In consideration for being permitted to apply for membership and/or for becoming a member of Diva Angels, Inc. I, for myself, my spouse, my children, my legal representatives, heirs and assigns hereby and for all purposes agree with Diva Angels, Inc. as follows:
 - i) That Diva Angels, Inc. shall not be liable for and I hereby release, discharge and acquit Diva Angels, Inc., for any and all claims for loss, damage or injury of any nature whatsoever to person or property resulting in anyway from or in any fashion arising from, connected with or participating in membership with Diva Angels, Inc. and their events, whether caused, in whole or in part, by negligent acts, simple or gross, of Diva Angels, Inc., its chartered chapters and their respective agents, members, officials, directors, servants, motorcycle owners, drivers sponsors, advertisers, employees or otherwise (“Released Parties”).
 - ii) That I shall indemnify Released Parties from any loss, liability, damage, or costs that Released Parties may incur due to my actions, participation, or presence during my membership with Diva Angels, Inc. or their chartered chapters and the events put on by Diva Angels, Inc. and/or its chartered events.
 - iii) That I assume full responsibility for the risk of bodily injury and/or death and/or property damage due to the negligence, simple or gross, of Released Parties or others while participating in Diva Angels, Inc. or its chartered chapters events.
 - iv) That I HEREBY RELEASE WAIVE, DISCHARGE AND COVENANT NOT TO SUE, Released Parties, from all liability to the undersigned, his/her personal representatives, assigns, heirs and next of kin for all loss or damage, and any claim or demands therefore, on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence, gross or simple, or Released Parties or otherwise while the undersigned is a Member of Diva Angels, Inc. or its chartered chapters.
 - v) That I HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence, simple or gross, of Released Parties or otherwise while participating as a member of Diva Angels, Inc. or while competing, officiating in, observing, working or for any purpose participating in event’s hosted by Diva Angels, Inc. or its chartered chapters.
- c Your membership in Diva Angels, Inc. does not in any way include or guarantee to you any insurance coverage of any kind.
- d THE UNDERSIGNED expressly acknowledges and agrees that the activities inherent with membership in Diva Angels, Inc. are very dangerous and involve the risk of serious injury and/or death and/or property damage. Knowing this I further expressly agree that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that if any portion thereof is held to be invalid, it is agreed that the remaining portion or portions shall continue in full legal force and effect.

By completing my membership application, and signing below, I AGREE THAT I HAVE READ THE ABOVE AND VOLUNTARILY AGREE TO BE BOUND BY ALL MATTERS STATED ABOVE. I further acknowledge that no oral representations, statements, or inducements apart from the foregoing written agreement have been made.

Member Guidelines

- **MISSION STATEMENT** To share in the love of biking and develop a special bond and camaraderie that is solely unique to women. Assist in empowering and enabling other women to ride and help them experience the joy that biking brings. Promote safety and responsible driving and set a good example in the community. Help others who are less fortunate than ourselves through fundraising events. And never, ever forget the fact that **WE ARE HERE TO HAVE FUN AND RIDE!**
- Any and all concerns and questions should be taken up with your chapter Director. If you need further help, feel free to contact a national officer: President, Donna DeFant at doozerdona@verizon.net, Vice President, Susan Goslin at divaangel@verizon.net, or Treasurer, Sandy Brandt at divaangelsandy@aol.com, or through the Contact Us area on the website.
- All group e-mails will be sent either from the Director or Activities Director through BCC for privacy of member's e-mail addresses. Individual members are not allowed to send group e-mails. Those should be sent first to the Director for both approval and distribution by the Director if found acceptable. No use of the member contact list, e-mail addresses, mailing addresses, phone numbers etc. for solicitation purposes is permitted. Violation of this is grounds for member termination.
- Always remember that you are representing all Diva Angels in public and should conduct yourselves with the moral standards that we represent.
- Our national logo and your local chapter logo are to be used for marketing and shirts. It should not be altered in any way. If you choose to design a logo of your own, please forward your designs to the National Board for approval.
- All new members sign an event release waiver with their application. Remember that whenever anyone (other than a member) rides with the group in a Diva Angel ride that they need to sign either an adult or minor event release form.
- We are a non-profit organization that states that all moneys will be donated to charities of our choice. When a chapter is considering support of a charity, please remember that it is to be a recognized, 501, non profit charity. Donations to other charities can be made by other means (i.e. 50/50 etc.).
- Chapter money should not be used for parties etc. Party funding should be funded otherwise (i.e., 50/50, pass the hat, bring your own etc.) and kept separate from chapter moneys.
- If conducting monthly meetings, meeting notes are to be sent to divaangel@verizon.net, for posting on our website. Anything you may want added to the website should be sent to Susan as well.
- Members must join local chapter within 60 days after joining national. If you haven't already, Membership to the National Diva Angel Organization is a requirement to join at any local chapter level. Dues can be paid on-line at divaangels.org, or mailed to Sandy Brandt.
- Attendance at monthly meetings is not a required but encouraged for all members. Having a bike is NOT a requirement.
- When attending group activities, please wear Diva Angel apparel.
- When group rides occur, KSU (Kick Stand Up) means that is the departure time. It is advised to arrive 15 minutes prior to KSU and with a full tank of gas.
- Each Director has a full copy of our Policies and Procedures handbook. If you have any further questions regarding policies, please talk to your chapter Director.
- **NO TOLERANCE POLICY:** Negative attitudes and destructive criticism and behavior will not be tolerated within our organization. Any criticism should be handled in a constructive way through the proper channels. Positive synergy is extremely important within each chapter and originates within each individual member. Our organization's bylaws allow us to terminate a membership at any time. No one person, including officers and even the directors are exempt from this policy. A breach of this policy can result in member termination. A warning would be issued first to the member and if the behavior continues, their membership will be terminated. It is an honor and privilege to be a Diva Angel.
